The minutes of the meeting of the Compassionate Appointment Committee.

2. A meeting of the Compassionate Appointment Committee consisting of the following officer was constituted vide this Office Order No. 548/2023, dated 22.12.2023 to consider the application for appointment on compassionate ground held on 26.12.2023:

However, Dr. S. I Kazmi, Scientist 'E', ZSI, Kolkata was not present in the said meeting.

- 3. The committee was informed the following provisions of the DoPT for Appointment of Compassionate Ground Scheme as consolidated in its OM vide No. DoPT-1667555281194, dated 02.08.2022:
  - a) That the Scheme is applicable to the dependent family member of a Government Servant who either dies in service or is retired on Medical Ground (hereinafter referred as Government Servant), and dependent family member means (i) Spouse, (ii) Son, (iii) Daughter and (iv) Brother or Sister in case of unmarried Government Servant;
  - b) That the appointment shall be made to Group 'C' Posts against the 5% vacancies of Direct Recruitment Quota;
  - c) That it is exempted from the purviews (i) SSC/Employment Exchange procedure (ii) Clearance from Surplus Cell of the DoPT and (iii) Ban orders on filling up posts issued by the Department of Expenditure of the Ministry of Finance, Government of India;
  - d) That the upper age limit could be relaxed wherever found to be necessary, but the lower age limit should in no case be relaxed below 18 years of age:
  - e) That age eligibility shall be determined with reference to the date of application and not the date of appointment;
  - f) That applicant for compassionate appointment should be eligible and suitable for a post in all respect under the provisions of the relevant Recruitment Rules, however, is relaxed for widow, in case of MTS post where minimum educational qualification is Matriculation (10<sup>th</sup>);

In exceptional circumstances, Government may consider recruiting person not immediately meeting the minimum education standard; subject to conditions that he/she may be engaged as a trainee till acquiring minimum qualification.

- g) That appointment on compassionate grounds should be made only on regular basis and that to only if regular vacancies meant for that purpose are available.
  - h) That the vacancies for appointment on compassionate ground is determined by grouping of posts using liberalizing method considering that the ZSI is a small office.
- 4. A Standard Internal Rules for considering the appointment on Compassionate Ground was adopted as advised by the DoPT vide Para 14 (VI) of the OM ibid, dated 02.08.2022 and circulated through the website of the ZSI vide this Office Order No. 383/2023, dated 30.08.2023.
- 5. Consequently, applicants were asked to submit the revised proforma alongwith certain documents and certificates from prescribed authority by 14.10.2023 which extended subsequently till 14.11.2023 vide OM No. 2-02/2023-Estt./, dated 15.09.2023 & dated 12.10.2023 in order to factual assessment of the assets, the liabilities, acute destitution and financial conditions of the deceased Government Servant and his/her dependents.
- 6. The Committee noted that the last meeting of the CAC was held on 01.11.2018 taking into account the Vacancy Year meant for the purpose upto 31.10.2018.
- 7. The Committee also noted that as per available record of this establishment, vacancies meant for appointment on compassionate Ground occurred with effect from 01.11.2018 to 31.12.2023 thereby grouping of posts using liberalized method in terms of the DoPT OM vide DoPT-1667555281194, dated 02.08.2022 considering that the ZSI is a small office are as follows:

Thus, there is total nine vacancies as on 31.12.2023 to be filled by Compassionate Appointment.

- 8. The Committee on verification and study of the concerned file noted that the ZSI received 34 applications as on 26.12.2023.
- 9. The Committee made the screening of all 34 applications and determined the merits of the applicants for recommending the appointment on compassionate ground.
- 10. The Committee while assessing the merit on account of money received as terminal benefits, it was decided, unanimously to use the price indexation of the Government of India in order to have parity as on date in respect of money received at different point of time.
- 11. The Committee assessed the Relative Merits point (RMP), out of maximum 100 points, based on the Standard Internal Rules notified vide this Office Order No. 383/2023, dated 30.08.2023 and awarded RMP to each of the applicants.
- 12. All the eligible candidates were given rank based on the total RMP score obtained by each applicants as assessed by the CAC, in descending order starting from highest score onward. In case where candidates scored same RMP, the applicant who applied before was ranked higher than the applicant who applied later. Based on such RMP scored by each applicants and their ranking a 'Matrix-Chart' is prepared and attached herewith at A/1.

## 13. Based on the Matrix-chart-

 a) the Committee recommends the following nine applicants for the appointment on compassionate ground at different post accordingly to their educational qualification and suitability:
