OFFICE MEMORANDUM

Subject: Consideration for Appointment on Compassionate Ground to any Group 'C' posts covered under Direct Recruitment Quota in ZSI – submission of certain certificates/documents.

I am directed to refer this Office Order No. 383/2023 endorsing therein a Standard Internal Rules to consider the application for appointment on Compassionate Ground in ZSI, uploaded in the official website of ZSI [i.e. zsi.gov.in] and to say that eight vacancies are to be filled up by Compassionate Appointment as observed by the Compassionate Appointment Committee (CAC) in the meeting held on 08.09.2023.

- 2. Consequently, the CAC has asked to submit following certificates, documents etc. in order to decide the merit of each applicants:
 - a) Revised proforma (enclosed herewith) of application for appointment on compassionate ground;
 - b) A Certificate from a State Government Authority should be furnished by the applicant to the effect that the applicant is the dependent of the Government Servant, in case where there is no office record of declaration made by the concerned Government Servant while in service;
 - c) A Certificate from a State Government Authority on his/her present status such as whether he/she is married/unmarried/widow and employed/unemployed;
 - d) A Certificate from State Government Authority stating that there is no earning member(s) in the family of government servant concerned, in case no earning member (s) is/are there in the family till date;
 - e) A certificate from State Government Authority should be furnished to that effect that the earning member(s) is/are not supporting the other members of the family and/or the income of the earning member(s) is/are also source of support of the concerned government servant with regard to his/her number of dependent, assets and liabilities left by him/her, in case there is earning member(s);

- f) A self-declaration on moveable property value other than scooter/two wheeler;
- g) A Certificate from State Government Authority should be furnished stating that "the family members of the government servants has/have no immovable property, other than one house [single stair, maximum 1000 sq. ft. or 1 housing site measuring not more than 60'x40'];
- h) A Certificate from the State Government Authority certifying the total value of immovable property held by the family members of the government servant is Rs.
 _____ should be furnished by the applicant, in case there is immovable property;
- j) Certificates/testimonials should be furnished by the applicant in support of his/her educational qualification;
- k) In case the applicant or any dependent member is physically handicapped, he/she should produce the prescribed proforma certificate issued by the Medical Authority;
- 3. For the purpose of this OM, the State Government Authority means any State Revenue Authority not below the rank of Block Development Officer or equivalent such as Municipality Commissioner, Sub-Registrar, Municipal Officer but not any people representative such as MP, MLA, Councilor, Gram Panchayat Pradhan, etc.
- 4. Further, the State Government Authority is hereby requested to issue certificates/documents as above on the strength of this Office Memorandum in order to decide his/her application for appointment on compassionate ground.
- 5. If the applicant fails to submit aforementioned certificate, documents, etc. from the authority prescribed in each case, the CAC shall award 1 negative point (-1) in respect of each omission/commission of the applicant.
- 6. Applicants are hereby requested to submit the certificates, documents, etc. (mentioned at Para. 2) by 14.10.2023, positively.
