OFFICE ORDER NO. 1 / 2024

In pursuance of the Department of Personnel & Training's Office Memorandum vide No. Misc.-14017/29/2024-PP(RR) dated 5th April, 2024, enclosing thereby a copy of Record of Discussions of meeting on implementation of Revised Flexible Complementing Scheme (RFCS) for Scientist, all the scientists of Zoological Survey of India are hereby informed of the some of the important observation made by the participants as briefed herein under: -

- Promotions under the Scheme are treated as promotion/upgradation instead of insitu promotion/upgradation;
- ii. Henceforth relaxation in minimum residency period irrespective of the level, shall be considered by Departmental Peer Review Committee (DPRC). The Scheme allows relaxation in residency period for not more that 10% of the eligible scientists.
- iii. It has been advised to revise APAR and AWR from 2024-25 onwards as per the annexures attached with the scheme.

In light of the above-referred observation, the dead-line set by issuing this Office Order No. 153/2024 dated 15th April, 2024 for submission of updated APAR and AWR as per the scheme is hereby withdrawn. Accordingly, the above mentioned observations should be taken into account while submitting APARs for the residency period concerned.

This issue is with the approval of the Director, Zoological Survey of India.
