OFFICE ORDER No. 01 /2026

In pursuance of Rule 18 (ii) of CCS (Conduct) Rules, 1964, the Government Servants belonging to Group 'A', 'B' and 'C' posts pertaining to Zoological Survey of India are hereby directed to submit the Annual Immovable Property Return (AIPR) for the year ending 2025 (as on 01.01.2026) before 31.01.2026.

2. Further, the Government Servants who have Government Mail Id must fill up the AIPR for the year ending 2025 (as on 01.01.2026) through e-HRMS 2.0 Portal (<https://e-hrms.gov.in/ipl>) and a copy of the printout duly signed by them should be forwarded to the undersigned.; whereas, rest who don't have the Gov. Mail are directed to submit the same in the prescribed format enclosed herewith before 31.01.2026.

3. Government Servant who fails to submit the AIPR in time may not be considered for Vigilance Clearance which is required to prepare Pension Papers, Passport, For consideration for empanelment for senior level posts in Government of India, etc.

4. While filing up the AIPR, it may be ensured that usage of phrases as 'same as previous year' or 'no change' are avoided and full particulars of the immovable property inherited by him/her or owned, or acquired by him/her on lease or mortgage either his/her own name or in the name of any member of his/her family or in the name of other person are furnished in terms of aforementioned Rule.

4. This issue is with the approval of the Director, Zoological Survey of India. Hindi version is being issued separately.
